Announcement Regarding Changes in Organization Structure and Changes in Executive Officers

Pan Pacific International Holdings Corporation ("the Company") announced change of organizational structure and executive officers as follows.

1. Organizational changes (effective July 1)

On July 1, 2020, we will restructure our organization by reorganizing the businesses of the Company and our subsidiaries along the three axes of In-house companies, Products, and Holdings company functions, and establishing an executive committee.

In recent years, by strengthening store openings in Asia, acquiring UNY Co., Ltd., and expanding stores in Japan, we have rapidly expanded the scale of our business in discount store business like Don Quijote, overseas retails, GMS, and financial businesses. It has become essential to strengthen governance, expedite decision-making in each business, and to manage a group management. In order to implement this policy, we have decided to carry out the following organizational restructuring.

The Executive Committee will be established to speed up the decision-making of each business and strengthen the governance. The Executive Committee is entrusted with the execution of business in accordance with the management policies determined by the Board of Directors. In addition, the Executive Committee delegates the execution of business in charge to the Presidents, Head of Business, and CMOs of each internal company. As a result, the Presidents, Head of Business, and CMOs of each internal company are delegated extensive authority and decision-making is accelerated. At the same time, we will strengthen our governance by constantly ensuring that through executive committee, the three axes; Company, Products, and Holdings will be able to communicate with each other.

On the other hand, the holdings company has a cross-company function and governance function. The holdings company is responsible for formulating group strategies, allocating group resources, formulating budgets, and managing progress. The holdings company is responsible for executing group-wide strategies, such as digital and marketing, with leadership of CMIO and CDO.

Through the enhancement of the holdings company function and the introduction of the Management Committee, we aim to strengthen governance and expedite the decision-making of the Group. By implementing these measures, we will incorporate the free and open opinions of executive officers and aim to further strengthen the management of the next generation. In the collection of our management philosophy, "The Source", we have stipulated that "ability to adapt" is our strength in business. In an era of major change, we will start the next fiscal year, starting on July 1, with a new organizational structure based on the important concepts of our management philosophy of "ability to adapt," "commit to creative destruction," and "to face the daunting challenges."
